### About this service

CountryWideBB provides residential broadband services using the nbn® network. Services may be delivered via Fibre to the Premises (FTTP), Fibre to the Curb (FTTC), Fibre to the Node (FTTN) or Hybrid Fibre Coaxial (HFC), depending on what is available at your address.

### Typical Evening Speeds

Typical Evening Speeds (7pm–11pm) for each plan are outlined in the table below. These plans are only available where the underlying nbn® technology supports the selected speed tier. **Not all speed tiers are available on all technologies (e.g., FTTN, FTTC, and HFC may have speed limitations).**

## Where is the service available?

## What do I need?

You will need an nbn-ready modem/router to use this service.

If installation is required, an adult aged 18 years or over must be present.

nbn® may install equipment inside and/or outside your premises.

### nbn® supplied equipment:

- **FTTP** services include an nbn® Network Termination Device (NTD).
- **FTTC** services include an nbn® Network Connection Device (NCD).
- **HFC** services include an nbn® Network Termination Device (NTD).

nbn® equipment is supplied at no cost; however installation or new development fees may apply.

## Phone services

CountryWideBB does not provide a home phone or VoIP service.

If you are migrating from a copper phone line, **your existing landline will be disconnected when the nbn® service is activated**. You cannot retain a traditional landline service through CountryWideBB, and existing phone wall sockets may no longer function.

If you require a phone service, you will need to arrange a VoIP or over-the-top phone service with another provider.

**Multiple copper lines:** If you have more than one copper line at your premises, a second line may be retained for a one-off nbn® fee (currently \$297). This second line will be disconnected 18 months after nbn® becomes active in your area.

## Bundling

No bundling is required. CountryWideBB does not offer a phone service. Optional add-ons, such as a static IP address, may be available on selected plans.

## Contract term

This is a month-to-month service with no minimum contract term.

## Modems and equipment

You may bring your own compatible nbn-ready modem/router.

Your modem/router must support the connection type required for your nbn® technology (e.g., DHCP for FTTP, FTTC and HFC; VDSL2 for FTTN).

No PPPoE authentication or VLAN tagging is required on CountryWideBB services.

Some ISP-supplied or locked modems may not be compatible with nbn® services.

CountryWideBB also offers modems for purchase either outright or via a repayment plan (for example, over 12 or 24 months). If you cancel your service before completing modem repayments, the remaining balance will be charged on your final bill. This charge is for the hardware only and is not an exit fee. Postage fees apply to hardware delivery.
